INFORMATION, RULES & REGULATIONS FOR ALL VENDORS

WHAT-WHERE-WHEN: The White Street BBQ Experience is in Wake Forest, North Carolina. Admission to the event is FREE to the public and will be held Saturday, March 10th on White Street and Owen Street in downtown Wake Forest (Use 218 S. White Street Wake Forest, NC 27587 for GPS). Event hours: Team Check-In on Friday the 9th from 5:00pm to 10:00pm and the festival will take place Saturday the 10th from 11:00am to 5:00pm. Vendors are permitted to set-up on Saturday from 7:00am to 10:00am however any vehicles that do not fit into the allotted space must be removed before 9:00am. SPACE ALLOCATION: Due to space constraints, vendors (and competition teams) must fit into their designated area. Trailer tongues, doors, awnings, signage, tables, etc. – ALL must be within the footprint of your assigned space.

DEADLINES: The vendor application portal will be available on January 8th, 2017.

Invitations to participate will be sent before the 31st.

Vendors must make payment for their space and any additional fees by Feb. 9th, or the invitation and space allotment will be forfeited. Payments to be by check and mailed to White Street Brewing Co., PO Box 2066, Wake Forest, NC 27588

REFUNDS: If you have paid for a vendor space and are unable to attend for some reason, please notify Will Haddock at 919.453.4170. No refund will be issued if cancellation occurs within 15 days of the event. **NOTE:** White Street BBQ Experience does not guarantee sales during the event. Refunds will not be issued due to poor sales performance. No refunds will be considered due to inclement weather.

WEATHER: The White Street BBQ Experience is an outdoor event and will be held rain or shine.

PROHIBITED ITEMS: The following items can NOT be displayed, sold or dispersed:

Firearms, pornography of any kind, controlled substances of any kind, drug related paraphernalia, and items deemed by the WSBE Committee to be offensive and/or profane.

White Street has the sole authority to determine if a vendor has violated this policy, and if it is concluded that they have, the vendor will be removed from the event with no refund or additional consideration.

ELECTRIC: Each food vendor may request 20amp service. All extension cords are the responsibility of the vendor. If power is required please notify your contact for assistance.

HEALTH DEPARTMENT: Food vendors will have additional qualifications to meet according to the laws of the Wake County Environmental Service. We will assist you obtain any TFE Permits required but you will be responsible for adhering to the health and fire codes.



FOOD VENDORS: ALL food vendors are required to post their menu items and prices during the event.

UNDER NO CIRCUMSTANCES ARE VENDORS PERMITTED TO SELL OR DISTRIBUTE BEER OR ALCOHOLIC BEVERAGES

VENDOR FEES: Two vending space options.

• Food Vendor: 10' x 20' area (open) - \$150.00

• Non-Food Vendor: 10' x 10' area (for tent only) - \$100.00

ACKNOWLEDGEMENT AND RECEIPT OF ALL VENDOR RULES AND REGULATIONS:

Once you have been accepted a signed copy of this information, "Information, Rules, and Regulations for All Vendors" must be returned to White Street along with your payment, acknowledging that you have read said form, and agree to abide by all items therein. Failure to return this form with your payment will result in your application being denied.
